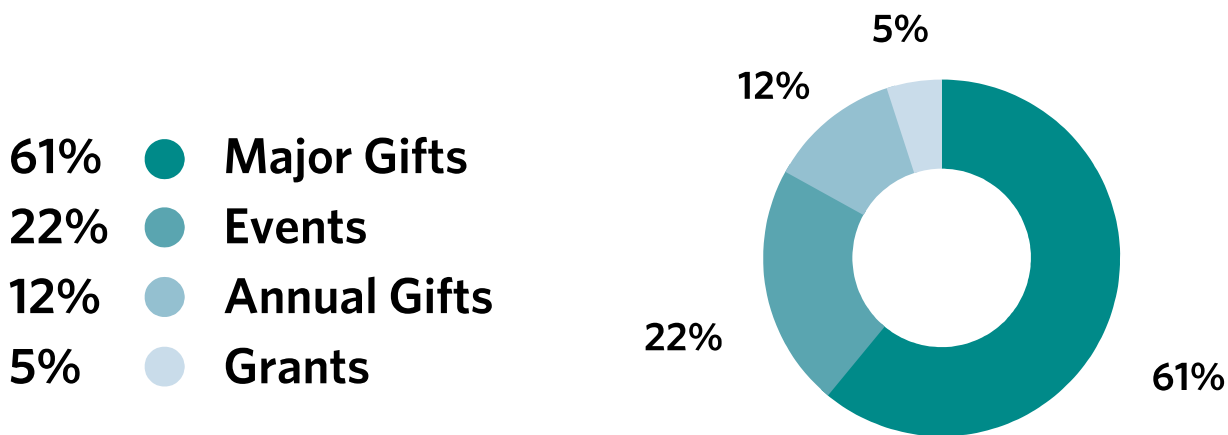
Fiscal year 2021 financial overview

(July 1, 2020 - June 30, 2021)

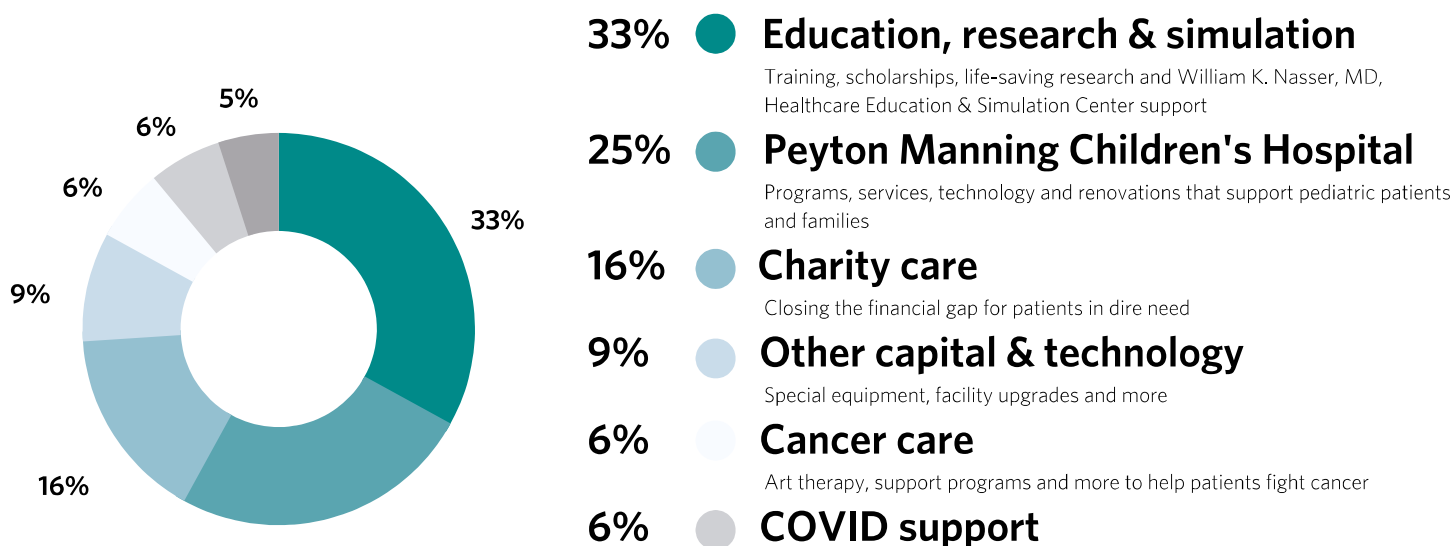

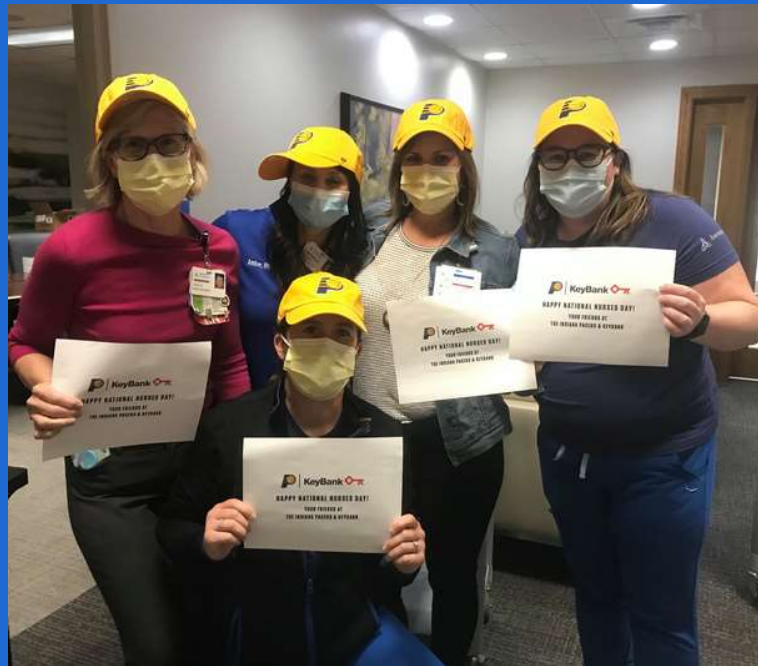
