A few highlights from the year

Ascension St. Vincent Evansville celebrated **150 years** of service and community collaboration, providing emergency medicine services, level II trauma care, medical-surgical care and maternity services including perinatal care for women and babies in high-risk pregnancies.



Ascension St. Vincent Renal Transplant Program completed its **800th kidney transplant**.



Peyton Manning Children's Hospital celebrated its **20th birthday**. Over \$60M has been contributed by generous donors to support the Children's Hospital and its pediatric services across the state over the years.



The Ascension St. Vincent Heart Center was recognized as the **largest and highest ranked heart program in Indiana**.



Ascension St. Vincent Fishers celebrated its 15th anniversary serving the Fishers and Noblesville communities.

Ascension St. Vincent Evansville and Ascension St. Vincent Carmel were included on **Newsweek's "America's Best Maternity Hospitals 2023"** list. The list names the 384 leading hospitals for maternity care in the U.S.



Peyton Manning Children's - St. John's Children's Clinic at Ascension St. Vincent Anderson celebrated 50 years of caring for the children of Madison County and its area communities. Associates celebrated the Clinic's 50th birthday at the 38th Annual Kids Classic.

The Ascension St. Vincent Kokomo Foundation marked its 50th anniversary. For decades, Foundation donors have provided gifts to purchase new equipment, technological upgrades, renovations, and patient services, such as mammograms and associate scholarships.



Connie Burgan, Cheer Guild President, presents Foundation Director Nancy Anderson with a \$30,000 check to be used for patient transportation. Since 1984, the Cheer Guild has donated \$1.4 million to the Foundation.

Ascension St. Vincent Anderson received ACS recertification as a level III Trauma Center providing higher acuity of care and allowing those in need to remain in the community for their healthcare needs.

Ascension St. Vincent Kokomo completed a three-year journey to become designated as a Baby-Friendly Hospital aiding in the reduction of infant mortality, which is one of Indiana's largest health challenges.

Jim and Marilyn Ault: High school sweethearts with a heart for service

Jim and Marilyn Ault are dynamic teammates that together have left a significant footprint on the Anderson community and Ascension St. Vincent. At 87 years old and with 67 years of marriage under their belts, Jim and Marilyn have served as co-chairpersons of the Ascension St. Vincent Kids Classic benefiting Peyton Manning Children's – St. John's Children's Clinic for 15 years.

Jim and Marilyn's involvement with the hospital began at a very young age. Marilyn was born in 1936 at the then named Saint John's Hospital. Jim had his appendix removed at the hospital when he was seven years old and both of their sons were born at Saint John's Hospital. They shared, **"Ascension St. Vincent has been an integral part of our lives and to Madison County. We are very fortunate to be involved with such a great organization."**

Helping others with healthcare needs, especially the poor and vulnerable, has always been a priority to Jim and Marilyn. They served as co-chairpersons of the Ascension St. Vincent Surgery Pavilion Campaign which raised \$1.5 million through their fundraising efforts for the 2015 opening of the pavilion. Jim has served on the Ascension St. Vincent Anderson Operations Board, Mission Integration and Finance committees and, most recently, is serving his first term on the Ascension St. Vincent Anderson Foundation Board. In addition to serving on the Kids Classic committee, Marilyn is a Victoria Guild Council Member. She also spent 10 years as an emergency department volunteer.

In addition to the many gifts Jim and Marilyn have made to the Foundation over the years, **they have designated the Children's Clinic as beneficiary of their designated endowment fund held at the Madison County Community Foundation. Their legacy of caring for Madison County's children will live on through this meaningful gift to the Children's Clinic.**

Your caring spirit changes lives

Meet a few of our patients who were touched by your generosity last year

Meet Braxton.

Braxton was born in January 2023 at 22 weeks gestation when his mother was just five months pregnant. He weighed 1 pound, 4 ounces and needed a breathing tube, breathing machine and multiple surgeries.

Thanks to his parents' enduring support and his Level 4 Newborn Intensive Care Unit (NICU) team of dedicated nurses, doctors and respiratory, physical, speech and occupational therapists, he went home weighing more than 10 pounds in September after 200+ days in the hospital!

"We are so excited to send Braxton home as he begins the next phase of his life outside the hospital. While we are always thrilled for patients like Braxton and his family, we also will miss him as **he became a part of our NICU family these past 202 days,**" said Dr. Jonathan Buechler, co-medical director of Peyton Manning Children's Hospital NICU. "I am so proud to be a part of this NICU and am humbled by all the work that led to Braxton's success."



Meet Carissa.

Carissa, a longtime pediatric oncology patient, participated in normal activities as much as she could throughout the year, including school. **Carissa attended school sessions in the hospital classroom as able, and Miss Heather, our hospital teacher, provided bedside sessions when she couldn't leave her room.** Miss Heather visited with Carissa's classroom at her school and introduced Monkey in My Chair to help her stay connected with her classmates when she was unable to attend in person. **More than 2,000 School Program sessions took place in 2023.**



Meet Maverick.

Maverick celebrated his end of treatment with an aviation themed bell-ringing surrounded by his family and care team members. Maverick was diagnosed with hepatoblastoma in April 2023 and was cared for by Dr. Bassem Razzouk. **Special end of treatment celebrations like this are made possible through the Child Life team.**



Meet Faith.

When chronic pneumonia and asthma sent Faith to Peyton Manning Children's Hospital in Evansville, her family was grateful for the exceptional care.

"All the staff - from the nurses, to the doctors, to the lab and x-ray technicians, worked in a coordinated effort with one goal in mind - finding an answer to bring about a quick and speedy recovery for our daughter. Care for Tomorrow

The Campaign for the Women & Children's Tower at Ascension St. Vincent

At the Celebration of Caring Gala in March 2023, Peyton Manning announced a special fundraising campaign that he is chairing to support patients and families at Peyton Manning Children's Hospital at Ascension St. Vincent—Care for Tomorrow.

The Women & Children's Tower will connect to Peyton Manning Children's Hospital and feature **one of the largest Neonatal Intensive Care Units in Indiana** with 109 private rooms, and **central Indiana's first 'couplet' rooms** to allow both moms and infants to receive treatment in the same room. In a state with some of the highest maternal and infant mortality rates in the nation, **the Women & Children's Tower will improve outcomes for moms and babies in need of life-saving care.**

Impact of Philanthropy

The generosity of donors like you allows us to go above and beyond in caring for our patients and families. To date, the following have been made possible:

- **Relocating the Hilbert Pediatric Emergency Department** to the Women & Children's Tower to help serve more patients
- **Expanding Critical Care Units** by adding 8 additional patient rooms to support the Newborn Intensive Care Unit (NICU), Pediatric Intensive Care Unit (PICU), and Cardiovascular Intensive Care Unit (CVICU) based on the current need
- **Creating a Pediatric Nurse Navigation Program** that will be supported by 2 dedicated staff members, offering families of pediatric patients a single point of contact to navigate the complex healthcare system
- **Supporting pediatric research** to continue to help with advancements that improve future outcomes

Ascension St. Vincent Mobile Dental Clinic receives support from Vanderburgh County Commissioners Office

"We are immensely grateful to the Vanderburgh County Commissioners Office for their generous donation," says Dr. John Anoskey, Dental Clinic dentist. "The Clinic would not be able to provide this life-changing care without the support of generous community donors. Through their support, children without access to dental care will be afforded the chance to smile, laugh, and eat without the pain from dental decay." A \$50,000 donation was made by the Vanderburgh County Commissioners Office in American Rescue Plan Act Funds.



The Mobile Dental Clinic cares for **1600 children annually**. It currently visits **47 different locations**, including **34 schools** within the Evansville Vanderburgh School Corporation.

Sometimes while in the hospital, many holidays can pass. Our Child Life team helps patients and families celebrate each one!



Child Life provided **15,103 interventions** to patients through special events, procedural distractions, development play and more.



Approximately **1761 vaccines** were provided to children at Peyton Manning Children's - St. John's Children's Clinic at Ascension St. Vincent Anderson whose families otherwise couldn't afford them.

Hyundai Hope on Wheels provides support for cancer patients

The Pediatric Cancer Care and Hematology Center at Peyton Manning Children's Hospital at Ascension St. Vincent treats pediatric cancer patients from throughout Indiana and beyond. The Center is heavily involved in clinical pediatric cancer research, mainly through its association with the Children's Oncology Group. The support of philanthropic partners plays a key role in these activities by supporting patient access to research-related testing and medications that are not covered by insurance or by the research sponsor. This helps ensure that every oncology patient is evaluated for possible inclusion in open clinical trials to determine the best course of treatment. Philanthropy also supports continuing educational opportunities for clinicians, nurses, pharmacists, and support staff at the Center.

In 2023, philanthropic support for the Center included a **\$100,000 donation from Hyundai Hope on Wheels**. A special "handprint" ceremony took place to celebrate this generous donation. As part of the ceremony, patients, families and staff stamped bright, painted handprints onto a white car and also on a white lab coat worn by Pediatric Hematology/Oncology Medical Director, Dr. Bassem Razzouk.

The Pediatric Cancer Care and Hematology Center is heavily involved in clinical pediatric cancer research, mainly through its association with the Children's Oncology Group (COG). The Center currently has **42 open COG protocols** for enrollment of patients, and **a total of 31 patients were enrolled on COG therapeutic and non-therapeutic clinical research trials during fiscal year 2023**. Overall, the Center is following more than 100 patients that have been enrolled on COG and industry-sponsored clinical trials over the past 10 years.



Anderson Center Day School celebrates first graduate

The Anderson Center has served individuals struggling with mental health and addiction in Madison County and neighboring counties since 1985. It includes a Day School for patients ages 6 to 18, which partners with Anderson Community Schools to meet the needs of students who need alternatives to a traditional classroom setting. The Anderson Center's Day School Program's first student recently graduated from the Day School! Anderson Community Schools in conjunction with the Anderson Center provided a Commencement Ceremony and presented Autumn Hannan her diploma. Ashley Stangland, Clinical Director for the Day School Program, and the Day School staff continue to provide an outstanding program for the community.

In 2021, dedicated supporters **Tina and Keith Burks, established the Tina Luzer Burks, RN, BSN and Keith Burks Nursing Scholarship.** This was the **first, and only to date, full ride scholarship** awarded by the Ascension St. Vincent Foundation.

Tina noted the “why” beyond her decision to create this scholarship: “I personally would not have been able to achieve my nursing profession if it were not for the extraordinary help of the two scholarships that I was awarded. **I am honored, along with my husband Keith, to be able to give back**

to others so they can pursue their dreams and passions.”

The scholarship was awarded to Lynnetta Mann, a certified surgical technician at Ascension St. Vincent Indianapolis Hospital. **Lynnetta has continued to work full time on the 86th Street campus while pursuing a BSN degree from Chamberlain College, and is expected to graduate in May 2023!** Lynnetta has already been offered and accepted a full-time job as an RN in the operating room upon graduation and is very excited to continue learning and honing her skills at Ascension St. Vincent.

Donors help purchase of new SIM Baby, "Val"

Did you know - Indiana ranks number three in the nation for maternal deaths?

To combat this, Ascension St. Vincent Women's Services staff and OB Physicians participate in simulations around OB hemorrhage and severe hypertension - risk factors during labor and delivery.

Veronica Collins, Women's Services Educator, shares, "Performing simulations with our multidisciplinary healthcare team is extremely beneficial. Nurses, physicians, and techs, despite our educational backgrounds and experiences, come together to work harmoniously at the bedside."

Simulations are particularly helpful in practicing serious situations that are not commonly seen by caregivers. After each simulation, the group participates in valuable debriefs.

With the support of generous donors of the Heritage Open at Ascension St. Vincent Evansville, a new sim mother, sim baby and additional equipment for the Simulation Lab have been purchased and are now in use by our teams! This updated equipment is vital to providing the highest quality patient outcomes for the women and newborns we serve.



Continuing education opportunities at William K. Nasser, MD, Healthcare Education & Simulation Center at Ascension St. Vincent

The William K. Nasser, MD, Healthcare Education and Simulation Center at Ascension St. Vincent plays a crucial role in addressing the evolving landscape of healthcare education. With a focus on simulation, the center provides state-of-the-art facilities and technology to replicate various medical settings, including operating rooms, intensive care units, and labor/delivery rooms.

Last year, the **Center educated 15,091 learners through 64,851 contact hours**, emphasizing its commitment to high-quality training. Beyond traditional education, the center provides a **low-risk environment for care team members to practice medical procedures** in the anatomy lab.

Notably, the center facilitated final interment for **8 medical donors, provided 43 medical donors to Graduate Medical Education programs, and conducted 4 research labs** to enhance healthcare safety. The commitment to continuing education spans various service lines and extends to partners like StatFlight, Perinatal/OB outreach, EMS providers, and Marian University College of Medicine.

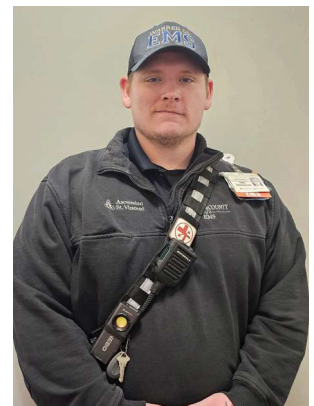

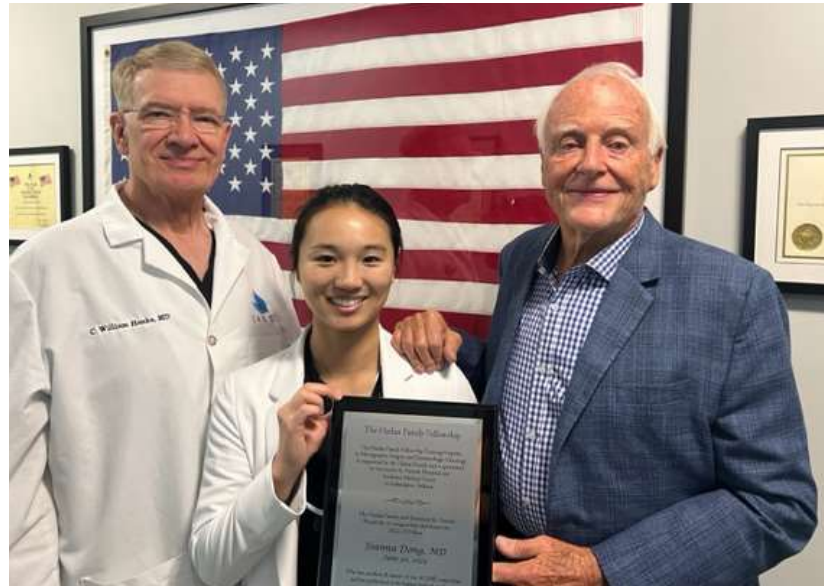

Nearly 40,000 served at Ascension St. Vincent Joshua Max Simon Primary Care Center



The Ascension St. Vincent Joshua Max Simon Primary Care Center (PCC) embodies Ascension St. Vincent's Mission by providing quality healthcare to thousands in need. Serving as an outpatient teaching facility, the PCC also contributes to the training of medical and surgical residents and fellows, emphasizing its commitment to education. Over the last year, the **PCC served 38,749 individuals, with 80% relying on government assistance or were uninsured.**

Patients benefited at the Primary Care Center

This impactful patient story highlights the compassionate care extended to those facing hurdles. A non-English speaking HIV-positive single mother with a special needs baby faced a delay in necessary surgery due to her lack of support. The PCC's social worker intervened, securing resources to find a suitable caregiver for the baby. This assistance enabled the patient to undergo successful surgery, averting potential complications from further delay.

The PCC's success is amplified by philanthropic partnerships that fund crucial activities and equipment.

Donations have helped support:

- Free colorectal cancer screenings
- Essential equipment, such as a new bilirubinometer for the Family Medicine Clinic
- Patient education programs, such as the Centering Pregnancy program
- Educational opportunities for medical residents and fellows through conferences, symposiums, and onsite events

Ascension St. Vincent Evansville Food Pantry blessed by St. Luke Physician Society

Ascension St. Vincent Evansville takes pride in providing a campus-based food pantry, offering emergency food rescue services for both patients and associates. Our pantry stocks essential items such as canned goods, pasta, cereal, diapers, baby items, hygiene products, paper goods, and other necessities.

The St. Luke Physician Society granted \$10,000 to support the Food Pantry. This impactful contribution ensures the continuity of emergency food rescue services for patients and associates facing immediate needs.



Trinity Behavioral Health Clinic helps patients like Annie

Annie Adams was a teenager when she experienced her first mental health episode. Upon entering the hospital's emergency department, Annie had attempted suicide, was hearing voices and suffered with severe anxiety and depression. She was placed on an emergency detention order by the Kokomo Police Department and was admitted to the Trinity Behavioral Health Clinic's inpatient unit.

After a five-day inpatient stay, Annie was stabilized on medications, given a diagnosis and information about her disease, and discharged to outpatient care for continued treatment. Over the years as a young adult, Annie continued her outpatient therapy and medication management with the help of the Trinity Behavioral Health Clinic's staff.

During the years after her initial diagnosis, Annie worked on managing her mental health. She recently completed her degree at Indiana University – Kokomo.

Annie said, " I am a survivor and my experience with Trinity Behavioral Health was life changing. I survived against all odds."

Last remodeled in the 1980s, Trinity's inpatient unit will receive a well-deserved update and new outdoor garden. With support from donors, the Howard County Community Foundation and proceeds from the Charity Golf Classic, patients like Annie will receive the care they need in a newly-renovated environment.

Annie added, " I was scared in that initial moment, but am proud to say I graduated from college and am now an advocate for mental health. I am proud to be an ongoing patient of Trinity Behavioral Health and Ascension St. Vincent Kokomo."



Transforming mental health through Colts "Kicking the Stigma" initiative

Ascension St. Vincent, in collaboration with the Indianapolis Colts Foundation, is taking significant strides in transforming mental health care thanks to a **\$75,000 grant provided by the Indianapolis Colts Foundation**. This grant, a part of the "Kicking the Stigma" initiative, supports a project aimed at training healthcare leaders and frontline workers to identify and respond to signs of mental health crises.

Led by experts from the Ascension St. Vincent Stress Center,

the project focuses on "QPR" training. QPR, standing for Question, Persuade, and Refer, equips participants with essential skills for crisis identification and intervention. The training empowers individuals to recognize signs of behavioral health crises, engage in competent persuasion, and appropriately refer those in crisis for professional help on their journey to recovery. This initiative represents a crucial step towards fostering a community that prioritizes and addresses mental health.

Pulmonary Care Clinic transformation at Ascension St. Vincent Jennings

Ascension St. Vincent Jennings, in collaboration with the National Rural Health Resource Center, was part of a pilot program to expand access to pulmonary care in rural communities. The pilot program focused on developing and implementing an evidence-based outpatient pulmonary rehabilitation program. As a result, **renovations were made to create a clinic space for the program, which donations to the hospital helped support.** Currently pulmonary patients in the community who need these services have to drive out of the county to other facilities. **This new clinic will provide patients with easier access to care, reducing COPD mortality rates, emergency visits, hospital readmissions and more.** Renovations were completed in 2023, with the clinic opening January 2024.



Meet Mirra

My name is Mirra Weir and I am an oncology navigator for Ascension St. Vincent Kokomo Cancer Center. I have witnessed first hand the impact of your support. **I became an oncology navigator shortly after completing my own personal cancer journey.** As a patient of Dr. Chris Leagre, I received radiation therapy at the Cancer Center. Oncology navigators help ensure seamless patient care

Oncology navigators play a crucial role in ensuring uninterrupted care by directly working with patients, streamlining care processes, reducing treatment delays, and improving communication with clinicians and care teams. Nurse Navigators offer a range of services, including appointment scheduling, connecting patients to community resources, providing education to patients and families, assisting with financial navigation, and offering emotional support. These services not only alleviate stress and frustration for patients but also contribute significantly to preventing hospital readmissions through the early identification of complications and facilitating timely interventions.

Last fiscal year, donor support assisted patient navigators to support **over 2,250 cancer patients** in **Anderson, Kokomo and Indianapolis communities.**

Cardiovascular Research Institute continues to provide access to top trials for heart and vascular patients

Launched in 2016, the Ascension St. Vincent Cardiovascular Research Institute is committed to bringing heart and vascular trials to Indianapolis to provide cutting-edge treatment options and ensure quality patient outcomes. Ascension St. Vincent's longstanding experience doing cardiovascular research began in the 1970's. Today, our heart and vascular patients have access to many of the same clinical trials being done at other university-based research centers and medical centers throughout the world, and this research is supported by generous donors.

Research by the numbers in 2023

- 75 providers participated in research
- 49 trials in active enrollments
- 50 trials in follow up and no longer actively recruiting
- 16 trials in the start up phase

Research highlights

- Completely funded two investigator initiative research projects thanks to donor support
- Implemented two new refrigerated centrifuges to support research needs
- Participated in four American Clinical Research Institute national trial endeavors
- Cardiovascular Research Institute became part of and served as a model for a new, national cardiovascular clinical trials support team, led by Kelly Verel with the Cardiovascular Research Institute
- Was a top enroller in the Proactive-HF (heart failure) trial, allowing the Cardiovascular Research Institute to be selected for Proactive-HF 2 with expedited feasibility
- Selected in the first wave of locations to be activated for enrollment in the ADVANTAGE AF (atrial fibrillation) study

Fighting obesity and diabetes through education and empowerment

Obesity has reached epidemic levels in the United States, and is directly linked to type 2 diabetes, sleep apnea, cardiovascular disease, and certain cancers, to name a few. At Ascension St. Vincent Randolph, care team members have taken measures to help prevent these chronic health conditions by offering patients realistic, easy to follow nutritional plans for lifelong wellness. Generous donations have been utilized to provide educational resources and books to diabetic and pre-diabetic patients to help educate and assist with weight loss and food management. Books are also made available for patients pre-diagnosis, as a means to help prevent diabetes.
