I am also grateful for all the accomplishments of 2009-10 we have to celebrate!

- \* We surpassed our budgeted fundraising goal!
- \* We received a grant from USA Funds to hire a full time teacher who will work with Peyton Manning Children's Hospital at St. Vincent patients to ensure their continued learning during treatment and to work with teachers of patients to make transitions back to the classroom easier.
- \* We received grants from the Glick Foundation and the Clowes Fund to hire an Art Therapist for Peyton Manning Children's Hospital at St. Vincent to help pediatric patients work through their fears and emotions during cancer treatments and hospitalizations.
- \* A campaign to raise funds to renovate St. Vincent Hospice culminated in a blessing ceremony in June resulting in updated patient rooms and family areas.
- \* In September, the inaugural 2-day, 38 mile walk, the Weekend to End Breast Cancer, brought the community together and raised money for St. Vincent women's cancer programs.
- \* Our trilogy of events – Peyton Manning Children's Hospital Celebration of Caring Gala, St. Vincent New Hope Golf Outing and Saks Fifth Avenue Key to the Cure – combined to raise over \$1 million for the St. Vincent Foundation.

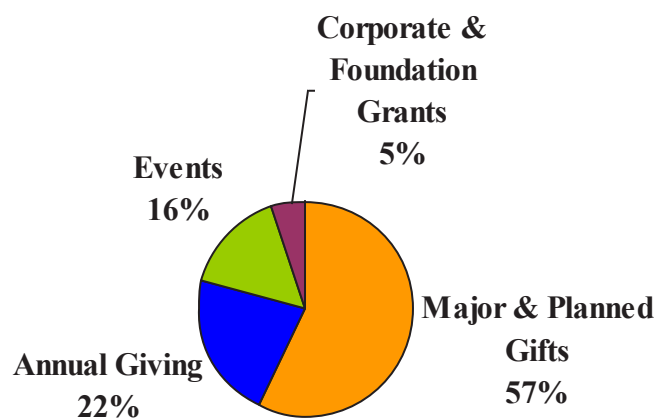

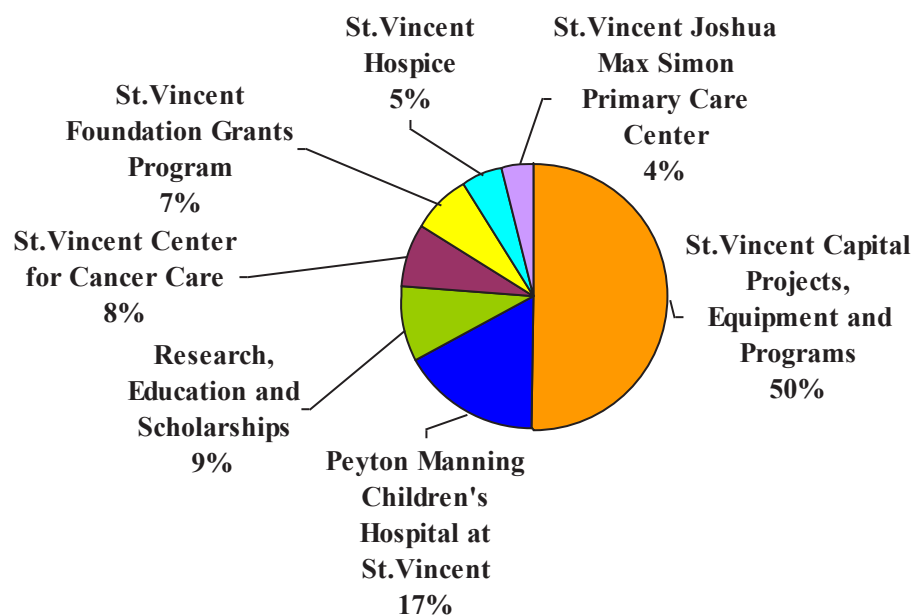
