It's been a great year, so it is hard to narrow down the list of the many ways you've impacted our hospitals. Below are just a few examples of the important programs that have benefited patients and families at St. Vincent!

**Super Hero Room at Peyton Manning Children's Hospital at St. Vincent:** A hospital stay can be a frightening experience for children. But being assigned to one of the themed and decorated rooms available can help relieve

anxiety and create a positive, encouraging environment for kids. This spring, thanks to the generous corporate support of Baldwin & Lyons, a Super Hero Room complete with action figures, capes and POW!, was dedicated. The room will inspire and delight our super hero pediatric patients at Peyton Manning Children's Hospital!

**St. Vincent Hospice Spiritual Gardens:** Anyone who has visited St. Vincent Hospice can't help but notice the beautiful grounds and gorgeous flower beds that are maintained through Foundation funds. The gardens are accessible from all patient rooms through patio doors that open to bird houses, benches, water features, and blooming plants and trees. The gardens exemplify the peace and grace with which patients and families are treated in this special place of transition.

**St. Vincent Cancer Care Art Therapy:** The efforts of participants in the St. Vincent Cancer Walk provided funding for one of the most therapeutic and meaningful programs at St. Vincent—art therapy. Through art, cancer patients find a means of expression and meaning often not possible through words. Several significant and beautiful mosaic pieces were completed by patients and families this year. These pieces now decorate the walls at St. Vincent Cancer Care and on the oncology floors at St. Vincent Indianapolis Hospital, providing inspiration and hope.

**NICU CPR Anytime Kit:** This year, a grant was provided by the Foundation to our Newborn Intensive Care Unit to provide free infant CPR Anytime Kits to parents of babies who were deemed to be at risk of heart-related health issues. In less than a year, the CPR kits have saved the lives of seven babies who had been discharged home! One grateful mother noted, "Thanks to the kit, I knew what to do!"

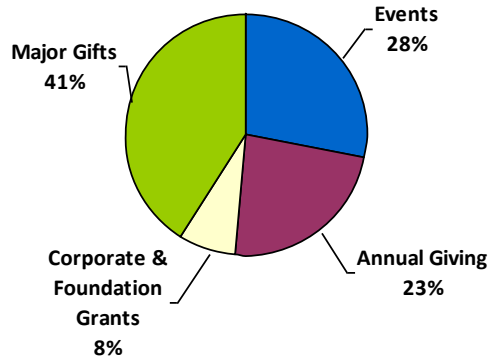

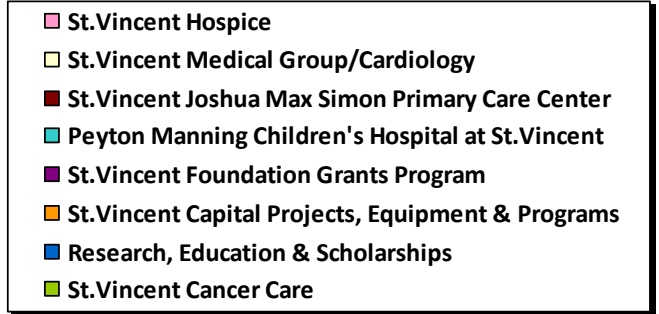
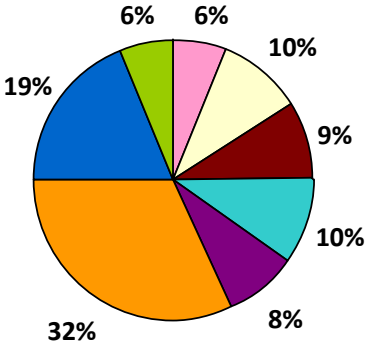
