Marco Ray used to be a teacher. A few years ago, he was called to something else.

"I believe in keeping families together when one of the members is hospitalized—I lived that need," said Marco.

As a donor, you keep patient families together by supporting the St. Vincent House. It's a big reason why Marco is so proud to work there.

When his youngest daughter Audrey

was three months old, his life changed. "She caught a respiratory virus, developed pneumonia, then the pneumonia went septic," Marco said.

Tiny Audrey had to breathe through tubes under intensive care.

"The medical care she received, and the care we received as her caretakers, set me on a new path." Marco said. Now he works at the St. Vincent House. He says, "Behind every act of mercy here, are many people. Donors, volunteers, staff; compassion is a gift offered by the whole community."

You, our donors, provide a warm, safe, and quiet place so that the caretakers in the family can regroup while caring for the patient.

Today Audrey is a healthy five-year-old.

"But I'll never forget how close we were to losing her, and how many people helped us during that traumatic time. I left teaching to do this work of hospitality, of caring for others when they have loved ones who are sick," said Marco.

Over the past two years, donors like you have given families a place to rest when a loved-one has to be hospitalized. The St. Vincent House is a safe harbor for families at the worst times of their lives. Families come from 60+ miles away and as far away as Puerto Rico. Through financial and volunteer support, donors continue to be there for families and it means the world!

Cancer could have stopped Randy in his tracks

Thanks to you, he's still in the race.

Randy Danko's prostate cancer diagnosis was tough. "I felt like I was swimming in mud. I needed some help."

Thankfully **you**, donors were there - you've made cancer support programs available at St. Vincent.

Randy came to St. Vincent as a patient of Dr. Alan Bercovitz, Medical Director of the Joshua Max Simon Primary Care Center at St. Vincent, beginning in 2013. "He and diabetes education programs (**also made possible by you!**) helped me get my diabetes under control with diet and exercise," says Randy.

Randy's care team also monitored his prostate health. Over the years they noticed his PSA (a protein produced by the prostate gland) levels were high - meaning there was a risk of cancer. Because of their diligent care, when Randy was diagnosed with Prostate Cancer in 2017 - his doctors were able to act quickly.

Randy is getting the support he needs thanks to programs you made possible! Support and meditation groups have helped give Randy tools to tamp down fear and anxiety, and *healing through fitness* has kept him active - he's still running in his high school's alumni 5K (left)!

"When you have cancer, it's not always easy for friends and family to understand exactly what you're going through. In the support group, there are people going through the same thing. Whether you feel hopeful, or fearful; once a week, you get to be with people who totally understand," Randy says.

"Being diagnosed with cancer is not the end of your life, it's the beginning of how you'll spend the rest of your life," says Randy. "You can either be down in the dumps, or you can get the most out of it."
